For consideration, the individual named above is applying for a Public Golf Pass for the 2024 season.

### **Conditions:**

1. Public Golf Pass is valid March 1<sup>st</sup>, 2024, through February 28<sup>th</sup>, 2025. Includes unlimited golf, cart and driving range privileges during the specified period.
2. Public Golf Pass does not include access to SBV POA amenities such as pools, tennis/pickleball courts or the fitness area. Nor does it include discounts at the LedgeStone Grille, Pro Shop, or invitations to SBV POA social events. Golfers who accompany a Public Golf Pass holder will pay the current public golf rate which can be found at [www.ledgestonegolf.com](http://www.ledgestonegolf.com).
3. SBV POA will provide a golf cart at LedgeStone Country Club to the pass holder for use during play on the golf course, said cart to be in good condition. Use of the cart will be limited to two (2) players and two (2) bags and no more than two (2) carts per group. Cart operators must be at least 16 years old with a valid driver's license.
4. No additional fees will be imposed throughout the duration of this contract. SBV POA, however, reserves the right to revise the policy and the fees for any future contracts. This contract is not transferable and non-refundable.
5. Exceptions: weather; availability; maintenance or outside event closures. Tee Times are available for reservation seven days a week and can be made up to \*60 days in advance. Online reservations can be scheduled 30 days in advance. To secure reservations 31 to 60 days in advance you must go through the Pro Shop staff either in person or on the phone.

*\*May – October, Public Golf Pass playing privileges are NOT valid Friday and Saturday before 12:00pm if the tee time was reserved more than two days in advance. The rate for reservations made outside the booking window is \$145+tax.*

6. A Family Public Golf Pass entitles the pass holder and spouse/significant other named above and \*\*Dependent Children by blood, marriage, or adoption under 20 years of age with permanent residence at the home to enjoy unlimited access to LedgeStone Country Club golf course and practice areas.

### **The Pass Holder(s) Agrees To:**

1. Return the SBV POA golf cart immediately upon completion of play in the same condition received, excluding normal wear.
2. Pay for any damage sustained to the SBV POA golf cart while in the pass holder's possession and pay for any damage to the facilities or grounds caused by the pass holder.
3. Abide by the SBV POA Rules and Regulations relative to the use of SBV POA golf carts and utilization of the golf course. Rules booklets are available on request. Please email [phillip@ledgestonegolf.com](mailto:phillip@ledgestonegolf.com)
4. Appropriate golf attire is required on the golf course or when using any of the practice areas. Golf specific shoes are not required but encouraged. Hard soled boots/shoes, high heels or anything that may damage the putting greens are prohibited.
